DISTRICT 209 SUPERINTENDENT DR. JESSE I. RODRIGUEZ HOSTS A COMMUNITY LEADERS BREAKFAST "ESTABLISHING PROVISO'S PATHWAYS TO SUCCESS"

On Thursday, December 7, 2017, Dr. Jesse J. Rodriguez, Superintendent, District 209, hosted a Community Leaders Breakfast "Establishing Proviso's Pathways to Success", from 9:00 a.m. to 11:00 a.m. at the District Office, 8601 West Roosevelt Road, Forest Park, Illinois.

Building upon Town Hall meetings held across the District in 2016, the foundation was laid for District 209's Strategic Plan ONE PROVISO—a collaborative approach for addressing achievement and opportunity gaps for all students.

In April of 2017, Dr. Rodriguez and his administrative team presented to the community the framework to District 209's Three-year Strategic Plan, that focused on strategic objectives and initiatives, aligned to District goals.

Continuing to "Establish Proviso's Pathways to Success" during the 2017-2018 school year, community leaders were urged to continue discussions with the District 209 Team, that will enhance academic achievement.

In the Village Free Press of 13 December 2017, Editor/Publisher Michael Romain provided a cogent and insightful account of the financial problems facing the Village after years of neglect and mismanagement.

Further, he set forth a list of questions that need to be asked and answered, concerning the Board's collective vision for the immediate and long-term future. Where is a five-year Capitol Improvement Program or a Long-term Strategic Plan, which can be utilized when trying to attract prospective developers. What means does the Board have of regularly tracking the progress of various Village Departments and Department heads? What are the ideas of the Board Trustees for reducing the property tax burden on average homeowners and business owners in the Village?

Finally, authorizing a budget is perhaps the single most responsibility of Board members and the attention they give to this task should be commensurate with its importance. The Maywood Board of Directors were urged to take a look at the best practices and due diligence of nearby municipalities, like Oak Park and River Forest, as well as the efforts of the Proviso Township District 209 Superintendent, Dr. Jesse J. Rodriguez in nearby Forest Park.

Maywood is, indeed, blessed to count Michael Romain as one of its citizens. He has not only provided us with a much needed Village newspaper, but has also challenged the citizens to demand more of its Mayor, Trustees, and Department Heads. We are all called to respond positively to his challenge to participate in the process of reform and growth.

ECONOMIC DEVELOPMENT MOVES FORWARD IN MAYWOOD AS PLANS FOR A SHIPPING COMPANY ARE PROPOSED ALONG ST. CHARLES ROAD

On Tuesday, 19 December 2017, during a regular Maywood Board of Trustees Meeting, Michal Usika, President & Owner of MIT Express, presented a proposal for the purchase of land along St. Charles Road between 9th Avenue and the Cintas property for the building of a domestic transportation facility.

MIT Express is a domestic shipping company, that is currently headquartered in Broadview and that has operations in four states. Michal Usika, President and Owner of MIT Express, pointed out that, in addition to engine overhauls and other truck repairs, the proposed Maywood facility would handle quick deliveries and drop-offs for companies like Amazon.
